Applicants must be eligible for one of the following two routes:

College Route

Initial CTE Certificates are issued in one of the following broad endorsement areas upon completion of a college/university state-approved teacher preparation program in the area, and 2,000 hours of paid occupational experience in the broad area other than teaching. Washington colleges approved to offer the endorsement are listed next to each broad endorsement area.

Business and Industry Route

Initial CTE Certificates are issued in one of the specific CTE specialties listed on the back. Documentation of 6,000 hours of paid occupational experience in the specific specialty and completion of a Washington state approved business and industry route program is required. Probationary CTE Teacher Certificate (valid for two years): [Applicants who do not qualify for the Initial CTE teaching certificate but have substantially completed the requirements for the Initial CTE Teacher Certificate and who are recommended by an employer, may apply for this certificate.]

Coordinator of Work-Based Learning Certificate

1. Hold a valid Initial or Continuing CTE Teaching Certificate.
2. Coordination Techniques - Must successfully demonstrate competency in coordination techniques as verified by a Professional Educator Standards Board approved program.

Probationary Certificate as a Coordinator of Work-Based Learning (valid for two years):

The candidate for a probationary certificate as a coordinator of work-based learning **must have demonstrated competency** in coordination techniques as verified by an approved CTE preparation program.

Hold a probationary certificate in another career and technical education teaching area.
